

ORDINANCE 1991-5

South Lyons Township Sanitary District  
Cook County, Illinois

AN ORDINANCE REQUIRING GENERAL LIABILITY AND  
WORKER'S COMPENSATION INSURANCE FROM ALL  
CONTRACTORS PERFORMING WORK ON, OVER OR ABOVE  
THE SOUTH LYONS TOWNSHIP SANITARY DISTRICT  
EASEMENTS AND/OR SEWER MAINS

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE SOUTH LYONS TOWNSHIP  
SANITARY DISTRICT, Cook County, Illinois as follows:

Section 1. All contractor or workmen performing work on, over or above easements, sewer mains, lift stations or any other facility owned, operated, maintained, managed or controlled by the South Lyons Township Sanitary District shall, before a permit is issued to perform said work, obtain and file with the District, proof that the contractor or workman has a valid general liability insurance policy with coverage up to at least one million dollars (\$1,000,000.00) and also a valid insurance policy to cover worker's compensation claim which policies indemnify the South Lyons Township Sanitary District for any worker's compensation or personal injury claims which may be made against the District during the course of said work.

Section 2. Penalty for violation of this Ordinance, and/or failure to provide the worker's compensation and/or general liability to the District before such work is commenced shall be a fine of not less than two thousand dollars (\$2,000.00) to be levied by a Court of competent jurisdiction upon suit by the District, in addition to any other damages for which the District may be held liable as a result of any acts performed by said contractor or workman.

Section 3. Any ordinances or parts thereof, in conflict herewith, are hereby repealed.

Section 4. The invalidity of any section, clause, sentence or provision of this Ordinance shall not effect the validity of any other part of this Ordinance which can be given effect without such invalid part or parts.

Section 5. All Ordinance and parts of this Ordinance not in conflict herewith shall remain in full force and effect.

Section 6. That this Ordinance after its passage and approval shall be in full force and take effect after its publication as provided by law.


