

ORDINANCE NO. 1992-5

SOUTH LYONS TOWNSHIP SANITARY DISTRICT  
(formerly operating as the Countryside Sanitary District)

AN ORDINANCE LEVYING TAXES FOR THE FISCAL YEAR COMMENCING ON THE 1ST DAY OF JUNE, 1992, AND ENDING ON THE 31ST DAY OF MAY, 1993 FOR THE SOUTH LYONS TOWNSHIP SANITARY DISTRICT, COOK COUNTY, ILLINOIS.

WHEREAS the Board of Trustees of the South Lyons Township Sanitary District (formerly operating as the Countryside Sanitary District), Cook County, State of Illinois, did on the 28th day of May, 1992, pass the annual appropriation ordinance for said sanitary district for the fiscal year commencing on the 1st day of June, 1992, and ending on the 31st day of May, 1993, therefore:

BE IT ORDAINED by the Board of Trustees of the South Lyons Township Sanitary District, Cook County, Illinois as follows:

**Section 1.** That a tax for the following sums of money or as much thereof as may be authorized by law, to defray expenses and liabilities of said Sanitary District be and the same is hereby levied for the purposes hereinafter specified upon all the taxable property located within the corporate limits of the South Lyons Township Sanitary District, Cook County, Illinois for the fiscal year commencing on June 1, 1992 and ending on May 31, 1993:


**Section 3.** That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.






