ORDINANCE 1993-5

**AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE SOUTH LYONS TOWNSHIP SANITARY DISTRICT,
COOK COUNTY, ILLINOIS (THE ROBB PROPERTY)**

WHEREAS, an annexation agreement signed by the legal owner of record of all land within the territory hereinafter described, has been filed with the District Clerk of the South Lyons Township Sanitary District, Cook County, Illinois, requesting that said territory be annexed to the South Lyons Township Sanitary District; and,

WHEREAS, the said territory is not within the corporate limits of any municipality, but is contiguous with the South Lyons Township Sanitary District; and,

WHEREAS, legal notice regarding the intention of the South Lyons Township Sanitary District to enter into said annexation agreement has been published in compliance with the law; and,

WHEREAS, the legal owner of record of said territory and the South Lyons Township Sanitary District have entered into a valid and binding annexation agreement relating to such territory; and,

WHEREAS, all agreements, documents and other necessary legal requirements are in full compliance with the terms of said annexation agreement and with the statutes of the State of Illinois, specifically Chapter 70, Section 32a./4a., Illinois Compiled Statutes, 1993; and,

WHEREAS, it is in the best interests of the South Lyons Township Sanitary District, that said territory be annexed thereto,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE SOUTH LYONS TOWNSHIP SANITARY DISTRICT, COOK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: THAT the following described territory:

Parcel 1.

A piece or parcel of land lying South of the Center Line of 5th Avenue in the Northwest Quarter of Section 28, Township 38 North, Range 12, East of the Third Principal Meridian described as follows: (Ex St) part beg at a point in the C/L of 5th Ave extended NELY to its intersection with the E line of NW 1/4 Sec. said point being 104 ft S of N line of Sec thence SWly along said C/L of 5th Ave 685-5/10 ft M.O.L. for a POB thence SEly at R/A to said CL 238-64/100 ft thence NELY par with said C/L 101 ft thence NWly at R/A to last described course 238-64/100 ft to C/L of 5th Ave thence SWly along CL of 5th Ave to POB

Parcel 2.

A piece or parcel of land lying South of the Center Line of 5th Avenue in the Northwest Quarter of Section 28, Township 38 North, Range 12, East of the Third Principal Meridian described as follows: (Ex La Grange Rd) and (Ex 5th Ave) and (Ex Southwest Expressway) and (Ex part com on E line 104 ft S of NE cor thence SWly along C/L of 5th Ave and said C/L extended NELY 685-5/10 feet for a POB thence SEly at R/A 238-64/100 ft thence NELY par'l with said C/L 101 ft thence NWly at R/A to last course 238-64/100 ft to said C/L thence SWly along said C/L 101 ft to POB) Par Com on E line 1111 ft S of NE cor thence NWly 471-6/10 ft at an angle of 88° 41' 30" with said C/L 5th Ave thence NELY par'l with said C/L 100 ft th NWly at R/A to last course 185 ft to C/L 5th Ave thence NELY along said C/L 501-25/100 ft thence SEly to a point on E line 764 ft N of POB thence S along E line to POB NE 1/4 NW 1/4

being indicated on an accurate map of the annexed territory, (which is appended to and made a part of this Ordinance) is hereby annexed to the South Lyons Township Sanitary District, Cook County, Illinois.

SECTION 2. THAT the District Clerk is hereby directed to record with the Recorder of Deeds and to file with the County Clerk a copy of this Ordinance, together with the accurate map of the territory annexed appended to said Ordinance.


SECTION 3. THAT this Ordinance shall be in full force and effect from and after its passage and approval.


