

Ordinance 2006-01

South Lyons Township Sanitary District Cook County, Illinois

AN ORDINANCE setting fees for the reproduction and certifying of any documents requested from the South Lyons Township Sanitary District under the Illinois Freedom of Information Act.

WHEREAS the Board of Trustees, as the corporate authority of the South Lyons Township Sanitary District, may charge fees reasonably calculated to reimburse its actual costs for reproducing and certifying public records and for the use, by any person, of the equipment of the Sanitary District to copy records,

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE SOUTH LYONS TOWNSHIP SANITARY DISTRICT, COOK COUNTY, ILLINOIS pursuant to the authority vested in them by 5 ILCS 140/6, entitled "The Freedom of Information Act."

SECTION 1. CHARGES FOR REPRODUCTION OF DOCUMENTS.

1. **Letter Size copies:** \$1.00 per page (approximately 8½ X 11 inches)
2. **Legal Size copies:** \$1.25 per page (approximately 8½ X 17 inches)
3. **Plat Size copies:** \$2.00 per page (approximately 11 X 17 inches)
4. **Larger than Plat Size copies:** \$2.50 per page

SECTION 2. CHARGES FOR CERTIFICATION OF DOCUMENTS.

1. **One Page documents:** \$5.00 per document
2. **Multi-Page (group) documents:** \$5.00 per document

SECTION 3. The invalidity of any section, clause, sentence or provision of this Ordinance shall not effect the validity of any other part of this Ordinance which can be given effect without such invalid part or parts.

SECTION 4. All ordinances and parts of ordinances not in conflict herewith shall remain in full force and effect.

SECTION 5. This Ordinance shall be effective after its passage and approval and shall be in force and take effect after its publication as provided by law.
