**AN ORDINANCE ASCERTAINING PREVAILING RATE OF WAGES
OF EMPLOYEES ON PUBLIC WORKS IN THE
SOUTH LYONS TOWNSHIP SANITARY DISTRICT FOR 2006-2007**

Whereas, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workers employed in any public works or any political subdivision of by anyone under contract for public works," approved June 26, 1941, as amended being 820 ILCS 130/1 through 130/12, and

Whereas, the aforesaid Act requires that the South Lyons Township Sanitary District investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the South Lyons Township Sanitary District in performing construction of public works, for said Sanitary District, exclusive of maintenance work.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE SOUTH LYONS TOWNSHIP SANITARY DISTRICT:

SECTION 1. To the extent and as required by "An Act regulating wages of laborers, mechanics, and other workers employed in any public works by State, county, city of any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of said Sanitary District is hereby ascertained to be the same as the prevailing rate of wages for construction work in Cook County area as determined by the Department of Labor of the State of Illinois as of June of the current year a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2. Nothing contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work of employment except public works construction of the South Lyons Township Sanitary District to the extent required by the aforesaid Act.

SECTION 3. The Clerk of the South Lyons Township Sanitary District shall keep available for inspection by any interested party in the office of the Sanitary District this determination or any revisions of such prevailing rate of wage. A copy

of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4. The Clerk of the South Lyons Township Sanitary District shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5. The Clerk of the South Lyons Township Sanitary District shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

SECTION 6. The Clerk of the South Lyons Township Sanitary District shall cause to be published in a newspaper of general circulation within the area, a copy of this Ordinance and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.


